- I. **ACJJP Member Roll Call and Welcome** - The meeting was called to order by the ACJJP Committee Chair at 10:10AM. DCJS staff member Natasha Fortune conducted a verbal roll call.

- IV. **Review of Bylaws** – Natasha Fortune presented and read through the ACJJP Bylaws as a reminder to committee members who have been on the committee for a while, and as a piece of orientation for new members. More orientation is forthcoming.
- V. **Vice Chair Election** – the previous Vice Chair’s term ended this past year, so the committee must elect a new Vice Chair. Ms. Fortune requested volunteers to serve on a small subcommittee to gather the necessary nominations and present them for a vote at the next meeting. - VI. **Making a Difference Conference Updates**
- Ms. Fortune thanked the members who have served on the Making a Difference in Juvenile Justice Conference subcommittee for its work over the past few months. They identified areas of focus and topics for the training. After the Office of Safer Communities held its Statewide Community of Practice Convening conference in December 2025, staff quickly realized the relevance of these sessions to the juvenile justice and delinquency prevention audience. It was decided to combine both events and hold one larger event, likely in March 2027.
